



Report of the Meeting of the Standing Committee on Staff and Financial Regulations

**26 September 2016
Phnom Penh – Kingdom of Cambodia**

The Standing Committee meeting on Staff and Financial Regulations of Asian Parliamentary Assembly held its meeting on 26 September 2016 in Phnom Penh, Kingdom of Cambodia. APA Delegations from Afghanistan, Bahrain, Bangladesh, Bhutan, Cambodia, China, Indonesia, Iran, Iraq, Kazakhstan, Kuwait, Lao PDR, Pakistan, Palestine, Russia, Sri Lanka, Thailand, Turkey, United Arab Emirates and Vietnam participated in this meeting. List of participants is attached (**Annex I**).

The meeting started at 10.30 a.m. The agenda of the meeting was adopted (**Annex II**). Honorable Mr. Irfanullah Irfan, Member of Parliament of Afghanistan chaired the meeting and Honorable Mr. Nhem Thavy, Member of National Assembly of Kingdom of Cambodia was elected as the Vice-Chairman. Mr. Chairman expressed his appreciation to the National Assembly of Cambodia for accepting to host this meeting at the side of 1st Executive Council which was supposed to be held by Afghanistan Parliament. He has expressed sincere regret for not being able to fulfill this commitment and cited certain political and security constraints.

Honorable Mr. Nhem Thavy briefly reviewed the outcomes of various APA meetings concerning the staff and financial regulations including the meetings of the special Ad Hoc Committee on Staff and Financial Regulation in Tehran

and Phnom Penh back in 2013 and 2014. He further emphasized the need for expediting the processes of financial self-reliance for the APA by implementing the method of assessed contributions by all member parliaments.

His Excellency Dr. Masoud Islami, APA Acting Secretary-General presented a report on the present financial situation of the APA, in which he provided background information and cited documents and resolutions which have been adopted in this respect since 2008, particularly the APA Staff and Financial Regulations and the scale of assessment for financial contributions by member parliaments which were considered and adopted by the 7th APA Plenary in Lahore, Pakistan.

The draft resolution which was prepared for consideration by the Executive Council and the proposed budget plan for 2017 which was attached to it were considered and discussed by the meeting. Issues concerning the principles and methods of scaling the assessing contributions by the Member Parliaments; the method of estimating the figures of the proposed budget; mechanisms for ensuring transparency; and modalities for financial commitment in internal procedures of each parliament; were discussed in details. Many delegations demanded extended time for further consideration of the matter and suggested different ways for planning the APA budget. Accordingly, it was decided that planning of the APA budget should be referred to the next meeting of Standing Committee on Staff and Financial Regulations in 2017. Following informal consultations by the interested delegations, the Secretariat prepared a revised draft resolution on planning the APA budget reflecting the main concerns of the participating delegations and suggests a way forward. The draft was circulated and then discussed in the meeting of the Executive Council on 27 of September 2016 and was adopted unanimously. The text of the draft resolution entitled Planning APA Budget is attached to this report (**Annex III**).

Draft Resolution on Planning APA Budget

EC1/Draft Res/2016/21
27 September 2016

We, the Members of the Asian Parliamentary Assembly,

Recalling APA/Res/2008/04 and APA/ Res/2014/09 and other relevant APA documents;

Determined to enhance the efficiency and organizational capacity of the APA to achieve its goals and objectives enshrined in its Charter;

Underscoring the importance of participation by all Member Parliaments in sharing the financial needs of the APA and its Secretariat;

Emphasizing the principles of transparency, accountability, and efficient management of financial resources in APA budgeting and spending;

1. **Request** all APA Member Parliaments to take required measures, according to their respective internal budget planning procedures, to secure budgetary resources required for the payment of their assessed contributions in accordance with the APA Staff and Financial Regulations and the schedule of assessed contributions approved by the 7th APA Plenary;
2. **Encourage** all APA Member Parliaments, particularly those with stronger economies to make voluntary financial contributions to the APA for the implementation of its resolutions.
3. **Appreciate** the provision of financial and logistical support to the APA Secretariat by the Islamic Parliament of Iran since 2007, and request the generous continuation of its supports pending the full implementation of Financial Regulations and until the regular payments of assessed contributions by all Member Parliaments are securely made;
4. **Acknowledge** the generosity of the APA President and Vice-Presidents in contributing to the APA expenses by hosting the events and complying with the APA Decision on Modalities for Effective Organization of the APA Meetings adopted by the 7th Plenary on 10 December 2013.
5. **Request** Member Parliaments to provide technical and expert assistance to the Secretariat for planning the APA budget for 2018 and include capable and experienced experts in their delegations to the next meeting of the APA Standing Committee on Staff and Financial Regulations in 2017 where the budget plan will be determined;

6. **Request** the Secretary-General to prepare a report on the proposals to be submitted to the Secretariat by the Member Parliaments on the best practices, guideline, and suitable patterns for planning and allocating budget, useful for planning the APA budget prior to the meeting of the Standing Committee of Staff and Financial Regulations in 2017.
