**Remarks:** The unfolding tragedy of the COVID-19 pandemic which has faced the globe with enormous critical challenges, calls on APA Parliamentarians to redouble their efforts in order to efficiently address the key issues, where ever possible, within the context of the draft resolutions with a different approach conducive to the prevailing situation.

that all such amendments should be drafted in a written form and be submitted to the Secretariat for further elaboration in the next Standing Committee.

#### 5. Draft Resolution of APA Women Parliamentarians

During consideration of this draft resolution at 12<sup>th</sup> Plenary Session in Antalya, Turkey, 2019, delegation of Indonesia presented comments and amendments. The Chair requested them to send amendments in a written form to the Secretariat for further elaboration in the next Standing Committee.

The draft resolution was slightly amended and adopted at 12<sup>th</sup> Plenary Session in Antalya, Turkey, 2019. Delegation of Turkey registered her reservation on China's amendment.

- 10. Draft Resolution on Protection and Promotion of the Rights of Migrant Workers in Asia (Deferred)
- At SC meeting in Bangkok, Feb. 2019, few delegates disassociated themselves from the preamble paragraph 5 of this draft resolution.
- During Executive Council Meeting in Rize, Turkey on October 2019, several delegations expressed their strong positions against the Form and Content of this resolution and requested its deletion from list of resolutions of this Standing Committee due to its adverse effects on security of some states. Others argued that we might change the title of this resolution to "Migrant/Foreign or Expatriate Workers". After a substantive exchange of views on the topic of resolution and its different terminologies, the meeting decided to defer consideration of the said resolution to the next Standing Committee.
- 11. Draft Resolution on the Promotion of Quality Child and Youth Development for Sustainable Society in Asia (New)

This new draft resolution was presented by the Thai delegation during the SC meeting on February 2019 in Bangkok.

12. Draft Resolution on Ageing Society in Asia (New)
